

**ANNUAL TAX LEVY ORDINANCE OF THE
SOUTHLAKE MOSQUITO ABATEMENT DISTRICT, LAKE COUNTY, ILLINOIS
FOR THE FISCAL YEAR BEGINNING MAY 1, 2014 ENDING
APRIL 30, 2015, FOR GENERAL CORPORATE PURPOSES**

An ordinance for the levy of taxes for the corporate purposes of the Southlake Mosquito Abatement District for the fiscal year ending April 30, 2015, covering Highland Park, Highwood, Deerfield, Bannockburn, Riverwoods and portions of unincorporated Lake County, Illinois.

WHEREAS, the Board of Trustees of THE SOUTHLAKE MOSQUITO ABATEMENT DISTRICT of Lake County, Illinois, did on the 9^h day of June, 2014, pass the Annual Budget and Appropriation Ordinance for said District for the fiscal year ending on the 30th day of April 2015, and appropriated an amount aggregating the sum of Six Hundred and Ninety Three Thousand Dollars (\$693,000.00) which said Appropriation Ordinance was duly published on the 18th day of September, 2014.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE SOUTHLAKE MOSQUITO ABATEMENT DISTRICT:

Section 1: LEVY. That there be and hereby is levied upon all taxable property within the territorial limits of said SOUTHLAKE MOSQUITO ABATEMENT DISTRICT, the total sum of Four Hundred and Eighty Six Thousand Dollars (\$486,000.00) for the following specific purposes mentioned in said Appropriation Ordinance in the respective sums as follows:

Section 2: NECESSITY. That each of said sums and the aggregate thereof are deemed necessary by the Board of Trustees of THE SOUTHLAKE MOSQUITO ABATEMENT DISTRICT to defray the necessary expenses and liabilities of said Mosquito Abatement District for the fiscal year ending April 30, 2015.

Section 3: FILING OF CERTIFIED COPY. The Secretary of THE SOUTHLAKE MOSQUITO ABATEMENT DISTRICT be and is hereby directed to file with the County Clerk of Lake County, Illinois, a certified copy of this ordinance, and said County Clerk of said Lake County aforesaid hereby is directed to cause the sum of Four Hundred and Eighty Six Thousand Dollars (\$486,000.00) be extended upon and against the taxable property within the territorial limits of THE SOUTHLAKE MOSQUITO ABATEMENT DISTRICT in accordance with the laws and statutes of the State of Illinois in such case made and provided.

Section 4: WHEN EFFECTIVE. This ordinance shall take effect and be in force from and after its adoption, passage and publication in pamphlet form.


